Sub: JNTUK – Estt., - Jagananna Vidya Deevena – Fee reimbursement - Payments to Mother's Account –Uploading student remittances information onto Jnanabhoomi Portal- Requested – Regarding.

I am by the direction wish to inform that, with reference to "**Jagananna Vidhya Deevena**" scheme individual communications have been sent to institutes for completion of the remittances into Mother's accounts. It is also intimated that serious action will be initiated, leading to cancellation of University affiliation, if the institute fails to complete the entire process vide communication in Ref. 3 cited. The colleges are also intimated to pay back the non remitted amounts to the Government, with the intimation to University vide Ref. 4 cited.

The details of the remittances are listed in table below. The table has the details of Student number and amounts to be remitted as per Jnanabhoomi Portal, College Records along with details of actually remitted.

From the details above it was intimated by the Colleges that there are differences among the three files due to the reason furnished below.

1. The list 1 included payments pertaining to first year students. The colleges did not initiate collection of any payment to first year students anticipating release of full fee reimbursement from the Government. *
2. The Principals intimated that, they are not in a position to update the student details in “Jnanabhoomi Portal” as it is not allowing to include the actual amounts remitted to the Mother’s account by not permitting to modify the payment field (Rs 35,000/-) as this figure is not uniform to all the students and hence the actual remittances are not reflecting in the portal. **
3. It is also brought to our notice that few colleges listed could not make payments due to inability to access accounts in view of their campuses are accommodating Covid containment (7 Colleges) and few colleges are verifying account numbers as the amount remitted bounced back (5 colleges) and others also remitted partial amounts (6 colleges) due to few above account related matters. ***

The issue of modifying the payment field (Rs.35K) into varying field was intimated to the Project Management Unit staff. The same has been modified as per the request of the Principals of the affiliated colleges.

Under the circumstances stated above the Principals of the affiliated colleges those who could not upload the student remittance information on to the “Jnanabhoomi portal” and also colleges who are in Covid confinements zones are hereby requested to update the student information onto the portal positively by **06-08-2020** with actual details, with a copy marked to University. Treat this as **MOST URGENT** as Government will be reviewing the scheme on 07-08-2020.
