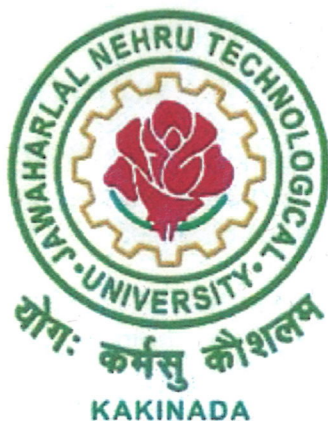

MEMORANDUM OF UNDERSTANDING (MOU)

JAWAHARLAL NEHRU TECHNOLOGICAL UNIVERSITY KAKINADA (Referred to as "JNTUK")
&

UNIVERSITY OF THE HIGHLANDS AND ISLANDS PERTH COLLEGE (Referred to as "UHIPC")

This Memorandum of Understanding between JNTUK and UHI records outline heads of agreement for the purpose of facilitating collaborative activity and academic links. This MOU sets out a framework of principles and the parties agree that they will work together in a spirit of cooperation to achieve the purposes set out herein. This MOU is non-exclusive in nature, it does not preclude either party entering into any form of agreement with other institutions.

JNTUK and University of the Highlands and Islands Perth College will work together to identify possible **Dual Degree Engineering programmes at UG and PG taught level courses** and also to extend to JNTUK affiliate colleges wherever possible.

1. PURPOSE

The purpose of this MOU is:

- 1.1 To encourage collaboration with respect to the various UG and PG taught level engineering courses in the near future.
- 1.2 To facilitate the possibility of direct entry to second or third year of various Engineering courses offered by UHIPC for JNTUK campus and JNTUK affiliated colleges.

2. CONTEXT AND CONDITIONS

- 2.1 JNTUK will recruit a cohort of students. The student numbers are to be agreed.
- 2.2 JNTUK will advise on any of their affiliated colleges willing to be part of this arrangement in consultation with UHIPC and subsequently signing into a tripartite MOU.
- 2.3 The parties recognise that detailed consideration will require to be given to assuring standards, managing quality, course delivery and articulation arrangements to ensure that such arrangements can be effectively and properly implemented.

3. INTENTION

- 3.1 It is the intention of both parties to this MOU that they will work positively and constructively together in relation to encouraging the development of collaborative activity.
- 3.2 The parties recognise as paramount the interest of students on all the programmes of study.

4. IMPLEMENTATION

- 4.1 Following the signing of this MOU the parties will negotiate the terms of an agreement to implement the matters set out in this MOU.
- 4.2 The parties will act in good faith in implementing the terms of the Agreement.

5. CONFIDENTIALITY

- 5.1 The terms of this MOU will not be disclosed by either JNTUK or UHIPC other than to their professional advisers.

6. LEGAL EFFECT

- 6.1 The parties agree and confirm that nothing in this MOU will impose any legal obligation on either of them or grant any legal rights or obligations to any party in respect of the other.

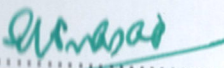
7. DURATION OF MOU

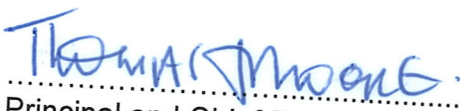

It shall however be reviewed every year to ensure compliance to the purpose and to make necessary revisions. Either party can terminate this MOU by giving thirty days notice without incurring any penalties.
