Sub: JNTUK-Affiliated Colleges- Payment of 50% of Affiliation / Common Services Fee dues to University-Reg

Ref: Resolutions of the XLII Executive Council Meeting of JNTUK, Kakinada, dated 23.10.2021.

You are aware that Individual letters have been sent to the all the Principals/ Managements of Affiliated Colleges to clear the pending dues, as per the details mentioned in individual letters. Further, it is clearly mentioned in the letters about Year wise outstanding dues of Affiliation and University Common Services Fee. Further, Vigilance and Enforcement Departments of respective districts have served notices to affiliated colleges of their jurisdiction to clear the dues immediately. More so, Government of Andhra Pradesh, Higher Education (U.E) Department has forwarded the High Court Judgment WP.NO.18703 of 2020 regarding recovery of the dues from the affiliated colleges of all the Universities and same information has also been circulated.

Vide ref cited, the University has permitted affiliated colleges for counseling in APEAPCET-2021 after clearing 25% of the due amount up to the Academic Year 2017-2018 and further instructed to clear the remaining 75% dues up to Academic Year 2017-2018 along with dues of 2018-2019, 2019-2020 and 2020-2021 Academic Years within two years.

In light of all these developments and as per the directions of Government, all the Principal/ Management Representatives of Affiliated Colleges are requested to clear 50% of out standing dues of Affiliation and University Common Services Fee (upto 2021-2022 Academic Year) on or before 08-08-2022. The colleges which do not comply this dues condition will not be permitted for ensuing admission counseling of all courses.
