SHE Foundation Hyderabad

For coordinating admission of Foreign Students in JNTU Kakinada

Memorandum of Cooperation

This Memorandum of Co-operation agreement has been entered into between

1. Parties

- i. JNTU Kakinada, Kakinada, Andhra Pradesh, India-533003, hereafter referred to as “**the Institution**” and
- ii. SHE Foundation, 503, SVS Papaiah Estates, Chikkadapally, Hyderabad- 500020, Andhra Pradesh, India, a Trust Registered at Hyderabad, A.P. hereafter referred to as “**the Trust**”.

IT IS HEREBY AGREED:

Based on mutual understanding, Jawaharlal Nehru Technological University Kakinada(JNTUK) and the SHE Foundation agree to the following with reference to admission of Students in 5 year IIMDP and other UG and PG Programs conducted jointly by Asian Institute of Technology, Bangkok, Thailand and JNTUK, Kakinada, India. This is also applicable to admission of Students belonging to the category of NRI/Pol/Foreign Nationals in any UG/PG/PhD/Training/Certificate Programs or any educational programs conducted by JNTUK, Kakinada, India.

1.1 In order to support JNTUK students applying or admitted to the Institution, the Trust will assist in various matters and offers professional services such as

i) Expert advice for residence permit, travel arrangements, banking issues, housing application etc. in Kakinada as well as Bangkok

ii) Offer other programs:-

a) Orientation / Motivation Sessions and Induction Training

b) Project / Time Management

c) Counseling Programs to aspiring students during admission process of JNTUK – AIT collaborated Programs with regular correspondence between JNTUK and SHE Foundation.

1.2 JNTUK will charge an additional fee equivalent to 6.25% of total tuition fee from every student enrolled in JNTUK-AIT collaborated IIMDP every year. However, the amount equivalent to 6.25% of total tuition fee for entire JNTUK-AIT collaborated program will be paid to SHE Foundation for their services, as one-time payment at the time of admission process of the JNTUK-AIT collaborated programs. In case, a student discontinues the program, the amount corresponding to the years for which he/she has not registered will be refunded by SHE Foundation to JNTUK. (For Example, if the total tuition fee for entire IIMDP is Rs. 10 Lakhs / Five Years, JNTUK will pay Rs. 62,500 as onetime payment. If the student discontinues, after 3rd year, then SHE Foundation will refund Rs. 25,000 to JNTUK). The same process will be applicable between JNTUK and


SHE Foundation for Students of category NRI/Pol/Foreign Nationals admitted through SHE Foundation in JNTUK for any of its UG/PG/PhD/Training Programs. SHE Foundation will strive for admission of students from a minimum of 10 different countries by 2012. SHE Foundation will also assist JNTUK in establishing collaborations with Universities in Asia, CIS, Europe, Russia, Australia, Africa, North America and South America and others.

1.3 The agreement contained within it will be valid until 30 July 2021. Both the parties mutually can go for any additional agreements or protocols in case of updations of this agreement.

1.4 Any dispute, controversy or claim arising out of or in connection with this contract, or the breach, termination or invalidity thereof, shall be finally settled in the jurisdiction of Kakinada court.



